Happy June 2022 neighbors!

In this Newsletter we would like to mention the recent tree trimming work, provide an update on the 2022 paint project, and a review of the Additional Assessment payment schedule.

We hope everyone is pleased with the **tree trimming work completed the week of May 16**th. In addition to maintaining the health and shape of the trees, another priority was to cut back tree branches that are touching the buildings. The tree trimming was scheduled before the painting, making it easier for painters to power wash and prep the buildings.

GetPro Painting has begun power washing and prepping three (3) buildings, starting with Saber Way, Emerald Chase, and then 100 Building of Park Green.

All items should have been removed from your porch, deck or balconies and around the buildings (Make sure to close items such as Screens, Windows, and Doors), as GetPro will not be responsible for personal belongings. Also, please move all cars out of the back of the building/garage areas, so that the painters can get to the building, and to prevent any overspray or drips from hitting your vehicle. As a reminder, the \$950.00/per unit Additional Assessment can be paid in one (1) lump sum, or in four (4) equal payments, payable over two years. Please contact AMI Accounting (accounting@amicondos.com) if you have any questions or need replacement payment coupons. Here is a recap of the \$950.00 payment schedule:

Option 1 – You can pay the entire Additional Assessment of \$950.00/per unit by June 10, 2022. or

Option 2 – **Unless you have automatic withdrawal**, you should have received four (4) <u>payment coupons</u> for \$237.50/each for a total of \$950.00. The four \$237.50 payments are due on June 10, 2022, December 10, 2022 and then again on June 10, 2023 and December 10, 2023. Again, please contact the AMI Accounting Department if you have questions.

These four payments are in addition to your regular monthly Association dues.

As always, thank you for your attention to these matters, and landlords please share this information with your tenants.
