## PRESIDENTS REPORT

Well, another Labor Day weekend is upon us and for some reason the TV weather personages seem to be so eager to declare an end to summer. There must be some sort of prize given to one who announces the end of what has proven to be an absolutely great summer season. I think one of the highlights of the season has been the "4th Friday Celebrations" held at the gazebo. These were truly great events and an excellent opportunity to sample some really good food and spend some quality time with your neighbors. Superior job Social Committee!

On the whole it has been a good summer for the Stony Ridge community. The drainage project that has been studied and fretted over for the past few years has been completed, and we should see a significant reduction in the amount of standing water in the rear yards of the homes in the central loop area, over the next year to eighteen months.

The following information is an extremely detailed treatise on two Stony Ridge issues, grass and ice. It is in our best interest for everyone to understand the "whys and wherefores" - so, please read on. (For those who don't know, I spent twenty-five years as the person responsible for turf grass management for the City of Troy.

I have been informed that there are some coowners who are concerned about the length of

the grass, and the quality of the product we are being provided by our mowing contractor. There are two things going on here. First is that mowing heights are always increased during the summer months. The science is that the more vegetative growth (the green blades of grass), the deeper into the soil the root system grows. The deeper into the soil the root systems grows, the cooler it is, which allows the plant to keep actively growing, which enables the plant to fend off disease problems, and helps to crowd out weeds. Another benefit of this practice is the turf is much more drought tolerant since it can draw on sources of moisture that are found deeper in the soil. All of this is good for Stony Ridge, because the lawn is very healthy; there is only a minimal need for herbicides, and disease and insect fighting pesticides, and we don't have to irrigate the lawns in our community so often which saves all of us MONEY.

This doesn't mean that there aren't areas where the turf grass is not a lot longer than I like to see it, and I'm positive that our contractor would like to see it shorter too. The problem is that within the last two weeks our Fertilization Contractor has made his late summer fertilizer application which has resulted in what agronomists call "Nitrogen Explosion" (not a very technical term). The condition occurs when there is an abundance of moisture (we've had a lot of rain lately), cool temperatures (while the daytime temps have been high, the nighttime has been in the 60's and 70's which is optimum for growing grass.) Add to this mixture nutrients, and the grass goes wild. This presents a very difficult problem for our mowing contractor because horticulturally the best practices indicate that no more than one third of the grass height should be removed at one time especially when hot summer temperatures are prevalent. Any

more than that and the grass plant becomes stressed and all the good that has been done all summer begins to deteriorate. As temperatures cool, the mowing contractor can begin to reduce his mowing height on a regular basis. I hope this short course in turf grass maintenance gives everyone a better understanding, and appreciation for the good work our mowing contractor has provided.

Another area of controversy (ice) deals with the installation of providing downspout underdrains for those downspouts that discharge from the gutter at the corner of our garages onto the driveway. During most of the year this isn't an issue, but during the winter months there is at times a buildup of ice which could result in a slip and fall situation. The Board first became aware of this problem a year ago when a new resident made a modification request to have an underdrain installed that would connect this corner downspout to a "French Drain" located in the front yard. The Board discussed the issue and decided that they had no major objection to the idea and did eventually approve the request. During the discussion one item that did come up was "what happens to the debris that accumulates in the gutter and would it in time clog the system rendering it useless?) We asked Mike to investigate to see if there was any type of cleanout system available on the market and how much would it cost.

During the winter (2014-15) AMI began receiving calls (10 calls) from co-owners, some of which were not only having issues with ice buildup on their driveways but in some instances, ice was forming in their garages. During this time a cleanout attachment was found and three contactors were offered the opportunity to bid on the project. As we put together our budget for 2015-16 we allocated

enough funds to install this system for those ten residents who called during the winter as a test to see how well the system works and to evaluate it against the underdrains without a cleanout. If next spring we find that the drain with the cleanout worked out well, we'll get new bids and hopefully become able to fund a much larger project.

Recently our member at large Debbie Novotny resigned her position because of other obligations and Tony Storto, acting vice president expressed an interest in taking that job and asked the board to find a replacement for him. We spoke to Karen Beger and she has graciously accepted and will be our vice president until that term expires in May 2016. Thank you Karen!

This is about all the space that has been allotted to me so I'll close now, but I look forward to seeing you all either at the mailbox kiosk (we'll be out of town for the September Fourth Friday Gazebo event) or at our annual Stony Ridge Christmas get together. Hope you all have a great autumn season.

#### TRASH PICK UP
