

## POOL RULES 2021

Pool passes will be issued to Stonehenge resident co-owners/renters in good standings. Co-owners behind on Association fees will not receive pool passes, this applies to the tenant of any Co-owner behind on Association Fees. In order to receive a pool pass, the co-owner/renter must present a valid Michigan Driver's License or Michigan ID card. The current Stonehenge address must appear on either form of state ID. Tenants must have a signed rental agreement as well as a valid Michigan Driver's License or Michigan ID card.

A Stonehenge pool pass or valid Michigan Driver's License or Michigan ID card with a current Stonehenge address are the only options for entering the pool or tennis court area. The first two pool passes are provided at no cost for their initial issue. A fee will be assessed for lost or stolen pool passes.

1. The pool is open currently from 11:00 a.m. to 7:00 p.m. Wednesday and Friday, Saturday and Sunday 11 a.m. to 7:00 p.m. weather and daylight hours permitting. A green flag is flown under the American flag at the clubhouse when the pool is open.
2. No lifeguard is on duty. All swimming is at your own risk.
3. The pool attendant has the authority to enforce all rules and regulations and to eject all violators from the pool area.
4. Stonehenge resident co-owners/tenants and guests must register in the record book before entering the pool. Guests of residents must be accompanied by the resident when using the pool.
5. Stonehenge resident co-owner/tenant, 15 years or older, are limited to maximum of 2 guests to the pool area at any one time.
6. All sun-bathers must shower before entering the pool area and after using tanning solutions, in order to avoid eye irritation and cloud water. The pool attendant has the authority to direct person/s with suntan oil/lotion to re-soap and shower before entering/reentering the pool.
7. All patrons within the pool area must wear proper swimming apparel. No street clothes are allowed in the pool. Cut-offs, gym shorts and underwear are not permitted as swimwear.
8. Shoulder length hair MUST be tied back securely when using the pool.
9. Children under fourteen (14) years old may swim if accompanied by a parent (adult). Children under eight (8) years old must have an adult in the pool with them at all times. Children under fourteen (14) do not have the privilege of bringing guest/s to the pool.
10. Infants/children who are not toilet trained and adults who are incontinent, must wear a clean swim approved diaper by separate rubber/vinyl pants, all of which must fit snugly around the legs and waist.
11. Small floatation devices or life jacket for toddlers or small children are the only items permitted in pool.

12. Residents, tenants and guests must exercise supervision over their children at all times while in and around the pool.
13. No running or other unsafe activities are allowed in the pool area at any time.
14. Swim toys such as tubes, rafts, balls, diving toys, squirt guns, etc. are not permitted in the pool area or pool.
15. No pets or animals are allowed in the pool, clubhouse area, or tennis courts.
16. Smoking, including, but not limited, to electronic cigarette, vaporizers, and hookahs, are not allowed in the clubhouse, patio area, pool, or tennis court.
17. Music devices, such as radios, are not permitted without using headphones within the clubhouse, patio area, pool, or tennis court.
18. No shoes may be worn in the pool area. (Shower shoes or thongs sandals are permitted if worn through shower and are visibly wet).
19. No wheeled vehicles (e.g., skateboards, bicycles, scooters, etc.) are permitted in the pool area, patio area and tennis court at any time, with the exception of vehicles for the physically challenged.
20. Food and beverages are only permitted in the fenced in patio area adjacent to the clubhouse.
21. Glass containers of any type are prohibited anywhere in the pool area, patio area or tennis court. Plastic water bottles are allowed in the pool area.
22. Contamination of the pool by any swimmer (a.e. feces, dirt, trash, or food) may require closing the pool for decontamination of the pool. The co-owner of the responsible party for the contamination may be charged up to \$500.00 to cover the costs of cleaning the pool.
23. Persons who have obvious infections (colds, lesions, open sores, etc.) shall not be allowed in the pool. This regulation also applies to those with inflamed eyes, colds, nasal or ear discharges, poison ivy, excessive sunburn, or any communicable disease. Determination is at the pool attendant's discretion.
24. Any and all injuries, however slight, must be reported to the office in writing, detailing the incident, as soon as possible.
25. Residents must inform their children of all rules and regulations for the pool.
